INSTRUCTIONS

I. PERSONAL INFORMATION

FINNISH PERSONAL DATA ACT

According to the Finnish Personal Data Act (HTL 523 22.4.1999) personal data can be given out to third parties for the purposes of historical or scientific research or to statistical analysis. Personal data can also be given out if it is required by law or regulation, for example the provision of information about the number of students and degrees to the Statistics Finland (Tilastokeskus), and the provision of attendance and grade information of students for the Social Insurance Institution of Finland (Kela). Address details can also be given out for the purpose of updating certain membership registers, providing that the recipient already has corresponding information in their own register and has the right to record personal information. For example, the Student Union and the Finnish Student Health Service (FSHS) have the right to uphold such registers. For any other purposes, the consent of the person in question is needed when giving out personal data.

Student organisations: Student organisations at faculties represent active parts of the student community in their respective fields. If you wish for your information to be available for the purposes of updating their membership registers, please tick "yes". Other student interest groups include national level student organisations.

Educational purposes: Tick "yes" if you wish your contact details to be available for purposes that can be useful for your studies. E.g. organised events, studies or courses that aim to promote the students' study environment, development of teaching or other closely related activities.

Recruitment purposes: Tick "yes" if your contact details can be given out to third parties for purposes that are beneficial for entering working life. These include bulletins from municipalities, organizations and companies who wish to inform students about job opportunities and entrepreneurship possibilities, available scholarships and research opportunities.

Student Card database: In order for you to be eligible for a student card, the university needs to submit confirmation of your student status and your personal, contact, and student details to the student card database.

University of Oulu Library customer register: If you consent to this your personal data can be transferred directly to the University of Oulu Library's customer database.
