History

As a discipline and subject, History is typically critical and diverse in nature. The studies of History comprise studies related to both research and teaching in General History as well as in Finnish and Scandinavian History, providing students with an understanding of the constant interaction between local and global phenomena.

When studying history, it is important to acquire an understanding of general historical thinking along with the ways and methods of finding historical sources peculiar to history as a discipline. It is also important to learn to produce information and draft presentations in accordance with the norms of the discipline. This is why methodology studies and related exercises, seminars and theses are of special importance. It is important to learn to ask questions, put things in their contexts by means of causes and effects, and tell the difference between the essential and the nonessential.

The studies aim to provide students with the ability to ask reasonable questions and provide answers to them. It is vital to learn to read, analyze and present historical information critically and consistently. The ability to produce good exam results and to write good theses in particular requires all this.

The subject is built on research of a high standard, the main areas of which are based on the staff's individual areas of specialization. From the beginning of their studies, students are provided with the opportunity to seek guidance from a researcher responsible for the selected area of specialization. As a rule, research is focused on Northern History in its various contexts, and, on the other hand, cultural interaction as a global phenomenon. In addition to research and teaching based on it, students are also provided with increasingly good opportunities to develop their abilities for the labour market.

Study packages in History

The Basic Studies in History are common to History and History of Science and Ideas, providing students with a general view of history and its key turning points from the viewpoint of two different subjects. Students are introduced to historical thinking as well as scientific writing. Methodology studies in particular contribute to building the foundation for understanding history as a discipline and to fostering the ability to use various research methods.

The aim of the Intermediate Studies is to further students' knowledge and methodological skills and to facilitate them with the ability to carry out independent scientific work.

The Intermediate Studies provide students with a broad approach to the main areas of history along with one or several areas that are of special research interest to them.

As part of the Advanced Studies, diverse theoretical and other specialized studies provide the student with the ability to carry out research on a significant historical phenomenon selected on the basis on his/her own interests as well as to produce related scientific information. Due to specialization, the student will acquire the abilities required for understanding the nature of historical or another type of information as well as for its analysis and communication. This will also contribute to developing the student's abilities for the labour market.

Admission requirements and commencement of studies

The subject of History is open to anyone registered as an attending student who has passed a separate entrance examination for the Basic Studies in History. History may be taken as a major subject by anyone who has passed the entrance examination arranged in the summer. It is also possible for an Oulu University student to take the Basic and Intermediate Studies first (with the minimum average grade of 3) and then apply from the Dean for permission to major in History and take the Master's Degree.

The curriculum of the History subject will be issued at the beginning of each semester. Details on possible information sessions are posted on the notice board designated for the subject.

Learning Objectives

After completing the Basic Studies students will have the knowledge, skills and conceptual abilities to critically analyse history and historical studies. They will have understood the nature of historical thought and become aware of the distinctive features and approaches of historiography. They will also have formed an overview of the course of history and its turning points. In addition, students will have the ability to produce short presentations, or other written or oral works, based on their own expertise.

After completing the Intermediate Studies, students will have a multifaceted view on the methods, approaches and source materials of historical studies. They will also have an understanding of the variety of research questions and the breadth of the field of historical studies. In addition, students will be familiar with the most important research traditions, methodological trends and the theoretical background of the methods in historical studies.

With reference to the master studies, students will have the skills to present and solve problems scientifically, to use existing information and sources, to document information, to propose arguments and critique and to participate in scientific dialogue. The students will be able to plan and produce small treatises which are based on their own expertise and effort as well as on applying scientific information and research.

After completing the Advanced Studies, students will be able to plan and carry out complex projects which require finding and using information. They will also have the abilities to produce scientific information. They will be able to work independently and ethically in demanding analytical and creative projects. They will also be capable of acting as experts in various groups and communities. They will have the skills to critically analyse different source materials and statements. In addition, they will have the skills to present the results of the research process coherently in written format. They will know and be able to implement the most important research methods of historiography. They will be accustomed to using the concepts of historiography. Furthermore, they will have the ability to use the theoretical tools and the methods from other fields of study. The students will have formed an idea of the diversity of historical studies and will be able to place their own research subjects into a wider scientific context. The students will be able to stay in touch with the scientific issues in their field of study independently. Through specialisation, they will have acquired profound capabilities in understanding, analysing and communicating historical information, or, in fact, any information.
