Our purposes of processing your personal data

In case you wish to attend the conference the provision of your personal data, as collected on the on-line form, is necessary for us to be able to organize the conference.

More specifically, we process the personal data we collect from you for the following purposes:

- Reviewing abstracts and communicating with their authors
- Designing the conference programme
- Organising and communicating practical matters related to conference venues, catering, etc.
- We need to inform the number of participants to our funder.
- Conducting new knowledge about cross-border mobility and recruiting practices.

Legal basis for our processing of your personal data

The collection and processing of your personal data is necessary for our legitimate interest in organising the network meetings and conferences and in collecting information with Cross-Border Mobility Questionnaire and focus group interviews with ICT companies.

Processors of your personal data

- All the personal data collected from you will be processed in accordance with the General Data Protection Regulation (GDPR). If the data is transferred outside the EU or the EEA, this is conducted according to data protection legislation.

Storage period of your personal data

- Full personal information as we collect here for purposes of networking meetings and conferences: From time of collection to ten years after the project duration. Abstracts and conference programme (including names and contact details) are storage ten years after the project duration.
- Cross-Border Mobility Questionnaire: Data will be made anonymous and all contact information is erased by the end of year 2019.
